2012 Spring and Summer Riding Day Camp

For Children Ages Seven through Sixteen, Beginner through Advanced Riders

PROGRAM INCLUDES:

- Camp schedule is from 9:30 AM to 4:30 PM, Monday through Friday.
- 2 rides daily – Lessons or Trail Ride. Fun Activities on Thursday afternoon.
- 2 lectures daily on Stable Management, Horse Care, Veterinary or Horse Shoeing.
- Campers' riding demonstration and award ceremony for Parents and Friends on Friday afternoon.
- Daily care of a horse/pony to include feeding, grooming, and stable management.

Available Weeks:

Summer: 6/11, 6/18, 6/25, 7/2, 7/9, 7/16, 7/23, 7/30, 8/6 and 8/13

Fee: \$420.00 on or before June 5, 2012. After June 5, camp fee is \$435.

Registration must include a \$100.00 **NON-REFUNDABLE DEPOSIT** per child per week and a *signed* release form. **The balance of \$320.00 for all summer camps is due on June 5. After June 5, the balance due will be \$335. If registering for summer camp after June 5, please pay in full, \$435. The balance of \$320 for spring camps is due 1 week before the first day of camp, April 2, 2012.** The balance is **NON-REFUNDABLE** for cancellations with less than two weeks notice. In case of injury, illness or family emergency prior to the beginning of your child's camp, the child may move to another camp week, depending on availability, or receive 10 weekly lessons. During your child's camp, any day missed due to illness or injury may be made up on another week of camp or applied toward weekly lessons. Payments may be made by check or cash. Parents will receive an email or a postcard confirming that their registration, deposit and release have been received. Parents, expect a phone call on Thursday or Friday before your child's camp from Pat Betts to discuss any last minute questions.

Transportation, if needed, is provided from Huguenot Village and Sycamore Square Shopping centers in Chesterfield County. Huguenot Village is located at the intersection of Robious and Huguenot Road. Sycamore Square is located on Midlothian Turnpike between Coalfield Road and Charter Colony Parkway. Please make your selection on the application. Pick up time is approximately 9:00 A.M. and drop off time approximately 5:00 P.M.

Campers should come to camp in shorts and tennis shoes and bring long pants, a helmet (a well fitting bike helmet is okay), and a shoe or boot with a flat sole and ½ to 1 inch heel for riding. (Please no boots with large treads.) Campers should also bring their lunch, drinks and snacks in a cooler. If rain is likely, please bring a change of shirt and raincoat, no rain ponchos please.

Level Green Riding School's day camp has been in operation for the last 25 years. Qualified and experienced staff members supervise all activities. Facilities include 45 horses and ponies, 39 stables, 2 riding rings, cross country course, and 200 acres of woods, pastures and riding trails. Level Green Riding School, Inc., is designed to teach basic horseback riding skills and foster greater interest in horseback riding as a sport and for general recreation. The parent or guardian must execute the following waiver as to the risks involved:
