Please note changes: This is a one ring horse show with 2 schooling breaks. The main ring has all-weather footing with good drainage and shade trees, with nearby large sand schooling area.

Awards and Regulations

This show is open to all competitors. It is a member of the Capital Horse Shows Association and a VHSA Associate show. This show is run in accordance with the current ground rules of the VHSA with the exception of height of the fences. Please refer to the Division Specs of the CHSA rules for further information, caphsa.org. Six ribbons will be awarded in all classes. A champion and reserve ribbon will be awarded in all divisions. **All riders** must wear an approved ASTM/SEI helmet at all times. Junior riders must be supervised by an adult at all times. A horse or pony must have been shown in at least one jumping class of a division in order to be eligible for the under saddle class. A negative Coggins test is required of all animals on the grounds.

We reserve the right to refuse any entry, to change the time schedule, to combine classes or change Judge at any time. No posted Jump Order with the exception of Equitation. The one-minute rule will be enforced, both for entering the ring and returning to jog. The Level Green Riding School Management will not be responsible for accidents or loss of property. Directions to Level Green Riding School, Inc.:

From 95 - North of Richmond: Take 95 south to 295 towards Charlottesville. Follow 295 to 64 west. Exit on 288 south then follow directions below.

From 95 - South of Richmond: Take 95 north to 288 north, then follow directions below.

From 64: Exit onto 288 south, then follow directions below.

From 288: Take the Huguenot Trail / Robious Rd exit (Route 711). Go west onto Rt. 711. Proceed west on Rt. 711 approx. 5 miles. Turn right onto Judes Ferry Rd, Rt. 614. Go a half of a mile turn right onto John Tree Hill Rd. Go a half a mile, turn a hard right at the top of a hill and continue on gravel farm road. Parking will be marked and on right.
